Licensed Therapist for Teen Support Group

In partnership with a licensed therapist NAMI KDK will bring a support group for teens 13-18. This group is currently piloting in Kendall County. With funding we hope to role this out to Kane and DeKalb. It will be free without eligibility requirements. We will pay the therapist or workplace so we may provide a safe space to learn about mental health and acquire skills.

Community Presentations in English & Spanish

Ending the Silence: a 50 minute in-school presentation about mental health designed for middle, high school students, parents, or staff. Students learn about mental illness directly from the family members and individuals living with mental illness.

In Our Own Voice: a presentation delivered from someone in recovery. This unique presentation shines light on the journey of someone's life experience with mental illness.

Custom Presentations: We meet with the community partner and learn the audience needs.

Sharing Hope and Compartiendo Esperanza: is a three-part video series that explores the journey of mental wellness in Black and Latinx communities through dialogue, storytelling and a guided discussion on the following topics:

Youth and Mental Wellness: "How Do You Heal?" Community Leaders and Mental Wellness: "The Art of Healing" Families and Mental Wellness: "Smiling On Our Journey"

NAMI Mental Health Education

Family to Family: 8 week course for family members and loved ones of those with mental health conditions

Family & Friends: is a free 90-minute or four-hour seminar that informs people who have loved ones with a mental health condition how to best support them. It's also an opportunity to meet other people in similar situations and gain community support.

NAMI Basics: is a 6-session education program for parents, caregivers and other family who provide care for youth (ages 22 and younger) who are experiencing mental health symptoms. This program is free to participants, 99% of whom say they would recommend the program to others.

NAMI Homefront: Mental Health Resources For Military Service Members, Veterans And Their Families: 6 week course

Peer-to-Peer: is a free, eight-session educational program for adults with mental health conditions who are looking to better understand themselves and their recovery.

Election Officers and Member to Board of Directors

ARTICLE VI

Meetings of the Members

Section 1. Annual Meeting and Notice Requirements.

An annual meeting of the Members shall be held each year at such time and place during the second quarter of the calendar year as determined by the President or the Board of Directors for the purpose of electing Directors and officers and for the transaction of such other business as may come before the annual meeting. Notice of annual meetings shall be provided to the Members not less than 30 days before the date of such annual meeting with the date, time and place of the annual meeting of Members to each individual entitled to vote at the meeting. The members holding one-tenth (1/10th) of the votes which may be cast at any meeting shall constitute a quorum at such meeting.



BYLAWS

No provision of the Bylaws to be amended or replaced shall be inconsistent with the organization's status as a nonprofit corporation under the laws of the State of Illinois or inconsistent with the organization's tax-exempt status under the IRS Code. NAMI Illinois must approve any changes to the Bylaws and no changes to the Bylaws are final until approval from NAMI Illinois is duly given. Such approval shall not be unreasonably withheld. The Bylaws must remain consistent with all relevant NAMI governing documents.
